

# **Our Privacy Policy**

Protecting your private information is our priority. This Statement of Privacy applies to <a href="https://www.cprlifesupport.com">www.cprlifesupport.com</a> (website, the "Site), and CPR Life Support Network, LLC ("Company", "CPRLSN", "we, "us" and/or "our") and governs data collection and usage. This privacy policy has been created to provide information about our company and to provide customized class registration services ("Company Services" to our Site visitors ("you", "your"). This Privacy Policy sets forth Company's policy with respect to information including personally identifiable data ("Personal Data") and other information that is collected from Site visitors.

# **Collection of your Personal Information**

In order to better provide you with products and services offered, CPRLSN may collect personally identifiable information, such as, when you contact us with inquiries, respond to one of our surveys, register for a class, register for access to the Company

If you purchase CPRLSN's products and services, we collect billing and credit card information. This information is used to complete the purchase transaction.

## **Use of your Personal Information**

CPRLSN collects and uses your personal information to operate and deliver the services you have requested.

CPRLSN may also use your personally identifiable information to inform you of other products or services available from CPRLSN and its affiliates.

# **Sharing Information with Third Parties**

CPRLSN does not sell, rent, or lease its customer lists to third parties.

CPRLSN may share data with trusted partners to help perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. All such third parties are prohibited from using

your personal information except to provide these services to CPRLSN, and they are required to maintain the confidentiality of your information.

CPRLSN may disclose your personal information, without notice, if required to do so by law or in the good faith belief that such action is necessary to: (a) conform to the edicts of the law or comply with legal process served on CPRLSN or the site; (b) protect and defend the rights or property of CPRLSN; and/or (c) act under exigent circumstances to protect the personal safety of users of CPRLSN, or the public.

# **Tracking Statistical Information**

CPRLSN may keep track of the websites and pages our users visit within CPRLSN, in order to determine what CPRLSN services are the most popular. This data is used to deliver customized content and advertising within CPRLSN to customers whose behavior indicates that they are interested in a particular subject area.

# **Automatically Collected Information**

Information about your computer hardware and software may be automatically collected by CPRLSN. This information can include: your IP address, browser type, domain names, access times and referring website addresses. This information is used for the operation of the service, to maintain quality of the service, and to provide general statistics regarding use of the CPRLSN website.

## **Right to Deletion**

- Complete the transaction for which the personal information was collected, fulfill the terms of a written warranty or product recall conducted in accordance with federal law, provide a good or service requested by you, or reasonably anticipated within the context of our ongoing business relationship with you, or otherwise perform a contract between you and us.
- Detect security incidents, protect against malicious, deceptive, fraudulent, or illegal activity; or prosecute those responsible for that activity.
- Debug to identify and repair errors that impair existing intended functionality.
- Exercise free speech, ensure the right of another consumer to exercise his or her right of free speech, or exercise another right provided for by law.
- Comply with the California Electronic Communications Privacy Act.
- Engage in public or peer-reviewed scientific, historical, or statistical research in the public interest that adheres to all other applicable ethics and privacy laws, when our deletion of the information

is likely to render impossible or seriously impair the achievement of such research, provided we have obtained your informed consent.

- Enable solely internal uses that are reasonably aligned with your expectations based on your relationship with us.
- · Comply with an existing legal obligation; or
- Otherwise use your personal information, internally, in a lawful manner that is compatible with the context in which you provided the information.

## **Children Under Thirteen**

CPRLSN does not knowingly collect personally identifiable information from children under the age of thirteen. If you are under the age of thirteen, you must ask your parent or guardian for permission to use this website.

### **E-mail Communications**

From time to time, CPRLSN may contact you via email for the purpose of providing announcements, promotional offers, alerts, confirmations, surveys, and/or other general communication.
